A	<b>GENERAL QUESTIONS</b>
1.	<p><b>What is the SkillsFuture Work-Study Programme?</b></p> <p>The SkillsFuture Work-Study Programme (WSP) was first launched at the Institutes of Higher Learning (IHLs) in 2015, in the form of SkillsFuture Earn and Learn Programme (ELP). The work-study modality of learning facilitates a stronger linkage between the curriculum taught in school, and the needs of the workplace.</p> <p>Since 2015, demand from individuals and employers for various work-study programmes has been healthy. We have also launched a range of new work-study modalities, such as the Work-Study Post-Diploma (WSPostDip), Work-Study Diploma (WSDip) and Work-Study Certificate (WSCert) programmes, to cater to increasingly diverse individual and employer needs.</p>
2.	<p><b>How is the SkillsFuture Work-Study Programme different from the SkillsFuture Earn-and-Learn Programme?</b></p> <p>The “SkillsFuture Earn-and-Learn Programme” was rebranded in 2019 to “SkillsFuture Work-Study Programme”, such as the Work-Study Post-Diploma (WSPostDip), Work-Study Diploma (WSDip) and Work-Study Certificate (WSCert) programmes, based on the qualification that the programme culminates in and the target audience.</p>
3.	<p><b>How long are the Work-Study Programmes?</b></p> <p>Work-Study Programmes range from 6 weeks to 4 years, depending on the level of study, sector, job and training requirements:</p> <ul style="list-style-type: none"> <li>• WSCert: 6 weeks to 18 months;</li> <li>• WSDip: 12 – 36 months;</li> <li>• WSPostDip: 9 – 18 months</li> </ul>
4.	<p><b>Who is eligible to participate in the SkillsFuture Work-Study Programme?</b></p> <p>Most Work-Study Programmes are available to Singaporeans and Singapore Permanent Residents who are within three years of either graduation from the ITE and Polytechnics or the Operational Ready Date for full-time National Servicemen. Exceptions apply to some WSCerts. Refer to the respective programme detail page for more information.</p>

<b>5.</b>	<p><b>What is the total number of participants that will be accepted into the programme?</b></p> <p>The total number of participants accepted may vary from sector to sector depending on the number of employers and vacancies available.</p>
<b>6.</b>	<p><b>Who are the employers under Work-Study Programmes, and how are they selected?</b></p> <p>Partner companies must be Singapore-registered or -incorporated. These companies are selected based on their ability and commitment to providing quality workplace training and meaningful career development opportunities for participants. Partners come from various sectors and include both MNCs and SMEs.</p>
<b>7.</b>	<p><b>Will participants be allowed to choose their preferred employer?</b></p> <p>Participants may indicate their preferred employer on the application form when they submit their application. Subject to the hiring and interview processes of each employer, participants may receive offers from more than one employer and may then select their preferred employer.</p>
<b>8.</b>	<p><b>Will participants be bonded to their employers?</b></p> <p>Generally, there is no bond imposed on the participant. However, for certain programmes, employers may impose a bond due to the high cost of training.</p>

<b>1.</b>	<p><b>What is the SkillsFuture Work-Study Diploma?</b></p> <p>The SkillsFuture Work-Study Diploma (WSDip) is part of the suite of SkillsFuture Work-Study Programmes offered by Institute of Higher Learning (IHLs) and appointed private providers by SSG, as well as the industry. Targeting at fresh graduates* from the Institute of Technical Education (ITE), WSDip provides them with a head-start in their careers related to their discipline of study and more opportunities to build on the skills and knowledge they acquired in school through a work-study arrangement.</p> <p>*Fresh graduates within three years of graduation or Operational Ready Date for National Servicemen</p>

4.	<p><b>Will participants be paid a salary during the programme?</b></p> <p>Yes. To be on this programme, applicants need to be shortlisted and interviewed by participating employer(s). Successful candidates will be offered a job with competitive industry starting salaries and relevant staff benefits. The starting salary is dependent on the job role/position, as well as the employer.</p>
5.	<p><b>Can I apply for Work-Study Programmes not related to my field of study?</b></p> <p>No. The programme is designed to give participants a head-start in careers related to their discipline of study.</p>
6.	<p><b>Who is eligible to participate in the programme?</b></p> <p>Targeted at ITE graduates who are Singaporeans or PRs and are within three years of graduation (based on the graduation date as stated on the NITEC/Higher NITEC certificates) or Operationally Ready Date for full-time National Servicemen may participate in the programme.</p>
7.	<p><b>Are employed ITE graduates eligible to participate in the programme?</b></p> <p>Yes, those who are already employed are eligible to participate in the programmes if they are within five years of graduation from ITE, and if their employer is a participating company. However the sign-on incentive will only be applicable for participants within three years upon graduation.</p>

<b>8.</b>	<p><b>Will participants be required to pay any fees?</b></p> <p>Participants will not be required to pay any course fees for the programme, as this will be borne jointly by the Government and employers.</p>
<b>9.</b>	<p><b>How much is the sign-on incentive?</b></p> <p>Each eligible Singaporean who is successfully placed on the programme will receive a sign-on incentive of S\$5,000, which will be disbursed in two tranches, subject to fulfillment of terms and conditions.</p>
<b>10.</b>	<p><b>Will participants be allowed to withdraw from the programme?</b></p> <p>Yes, participants who withdraw from the programme will be required to return the sign-on incentive. Participants are strongly encouraged to complete the programme so that they can realise its benefits. Participants who join another participating company in the same sector and are able to complete the Programme are eligible for the full sign-on incentive. Please contact your respective Programme Manager for assistance.</p>
<b>11.</b>	<p><b>Will participants have to return the sign-on incentive if they are asked to leave, or if their employment has been terminated by the employer?</b></p> <p>Participants who are asked to leave, or have their employment terminated by the employer, will be required to return the sign-on incentive. Exceptions may be granted on a case-by-case basis, based on considerations of the extent of the individual's commitment to the programme, conduct during the programme, control over the withdrawal etc.</p>
<b>12.</b>	<p><b>Will participants have to return the sign-on incentive if they join another firm which is also on the programme?</b></p> <p>Participants who join another participating company in the same sector and are able to complete the Programme may be eligible for the full sign-on incentive. The Programme Manager will assess each case, taking into account the impact on the employer and the participant's ability to complete the programme.</p>

<b>1.</b>	<p><b>What is the SkillsFuture Work-Study Post-Diploma?</b></p> <p>The SkillsFuture Work-Study Post-Diploma (WSPostDip) is part of the suite of SkillsFuture Work-Study Programmes offered by Institute of Higher Learning (IHLs) and appointed private providers. Targeting at fresh graduates* from the Polytechnics, WSPostDip provides them with a head-start in their careers related to their discipline of study and more opportunities to build on the skills and knowledge they acquired in school through a work-study arrangement. In addition, articulation pathways into degree programmes at Autonomous Universities are also available for selected WSPostDip.</p> <p>*Fresh graduates within three years of graduation or Operationally Ready Date for full-time National Servicemen</p>

<b>3.</b>	<p><b>How long is the programme?</b></p> <p>The duration ranges from 12 to 18 months depending on the programme, sector, job and training requirements.</p>
<b>4.</b>	<p><b>Will participants be paid a salary during the programme?</b></p> <p>Yes. To be on this programme, applicants need to be shortlisted and interviewed by participating employer(s). Successful candidates will be offered a job with competitive industry starting salaries and relevant staff benefits. The starting salary is dependent on the job role/position, as well as the employer.</p>
<b>5.</b>	<p><b>Can I apply for Work-Study Programmes not related to my field of study?</b></p> <p>No. The programme is designed to give participants a head-start in careers related to their discipline of study.</p>

<b>7.</b>	<p><b>Are employed Polytechnic graduates eligible to participate in the programme?</b></p> <p>Yes, those who are already employed are eligible to participate in the programmes if they are within five years of graduation from Polytechnic, and if their employer is a participating company. However the sign-on incentive will only be applicable for participants within three years upon graduation.</p>

<b>D</b>	<b>QUESTIONS ON WSCERT</b>
<b>1.</b>	<p><b>What are the SkillsFuture Work-Study Certificates (Modular Certificates and WSQ Certificates) about?</b></p> <p>The SkillsFuture Work-Study Certificate (WSCert) is part of the suite of SkillsFuture Work-Study Programmes (WSPs) offered by Institute of Higher Learning (IHLs) and appointed private training providers. WSCert provide individuals with more opportunities, to develop new skills and knowledge, and build on what they have acquired in school, through a work-study arrangement. All WSCerts with the exception of the WSCerts in Digital Marketing and Branding / for Engineer 4.0 / for Customer Service Associate are between 12 to 18 months in duration.</p> <p>Participating employers can recruit local graduates and prepare them to take up suitable job roles. The programme is designed in collaboration with industry to ensure relevance to employers in the sector.</p>
<b>2.</b>	<p><b>What are the SkillsFuture WSCerts in Digital Marketing and Branding / for Engineer 4.0 / for Customer Service Associate about?</b></p> <p>The SkillsFuture WSCerts in Digital Marketing and Branding / for Engineer 4.0 / for Customer Service Associate are new work-study programmes that will equip individuals with the relevant job-role specific behavioural, mind-set and technical skills in sectors with acute demand. This pilot programme is developed in partnership between SSG, the five polytechnics, ITE and Generation. Generation is a US-based non-profit organisation founded by McKinsey &amp; Company.</p> <p>Participants will undergo an 6 to 12 weeks of intensive institutional training before seeking employment. These programmes involve employers extensively throughout the process, from developing industry-relevant curriculum to identifying suitable participants for the programme and recruitment. As an illustration, the polytechnics and ITE, together with Generation, will work with employers to identify skills found in peak performers in the specific job role, and design a bootcamp-style programme to train participants in those skills.</p>
<b>3.</b>	<p><b>Who is Generation?</b></p> <p>Generation is a US-based global non-profit organisation founded by McKinsey &amp; Company. It develops and implements youth employment programmes that train and place young people in jobs using its unique methodology which has proven to be scalable and effective. Generation’s youth employment programs target sectors with acute skills and manpower demands, by incorporating short training for youths developed in tight collaboration with industries and working with employers to place suitable youths into their companies.</p>

<b>5.</b>	<p><b>Will participants be paid a salary during the programme?</b></p> <p>Yes, for all WSCerts with the exception of the WSCerts in Digital Marketing and Branding / for Engineer 4.0 / for Customer Service Associate, participants will be offered a job with competitive starting salaries as part of the programme. Salaries will vary between companies, job roles, and industries.</p> <p>For WSCerts in Digital Marketing and Branding / for Engineer 4.0 / for Customer Service Associate, participants will not be paid a salary during the 6 to 12 weeks of training. However, participants will receive a training allowance upon completion of the training.</p> <p>After the training, graduates will go through an interview process with the participating employer(s). Successful candidates will be offered a job with competitive industry starting salary and relevant staff benefits. The starting salary of the participant depends on the company and job role/position.</p>
<b>6.</b>	<p><b>What kind of industry qualifications / certificates will I get?</b></p> <p>Participants will receive a certificate of completion issued by respective training partner offering the WSCert.</p>
<b>7.</b>	<p><b>Will graduates who attend the WSCerts in Digital Marketing and Branding / for Engineer 4.0 / for Customer Service Associate be guaranteed a job at the end of the training?</b></p> <p>Graduates who successfully complete the programme will be given opportunities to interview with prospective employers. Successful graduates will subsequently be offered placement. The interview process enables better matching to take place between the employer and individual.</p>

<b>8.</b>	<p><b>Can participants pursue a part-time degree/part-time work during the course of the programme?</b></p> <p>While we do not restrict participants from doing so, it is useful to note that the WsCert is a rigorous training programme that requires participants to attend lessons over the stipulated duration. As such, it may be difficult for participants to pursue other qualifications/work during the course of the programme.</p>
<b>9.</b>	<p><b>Can I apply for WSCerts not related to my field of study?</b></p> <p>No. The programme is designed to give participants a head-start in careers related to their discipline of study.</p> <p>However, individuals keen to pursue the WSCerts in Digital Marketing and Branding / for Engineer 4.0 / for Customer Service Associate may apply to the programme even if they do not have a relevant qualification. Successful applicants will undergo intensive training over 6 to 12 weeks to acquire job-specific behavioural, mindset and technical skills.</p>
<b>10.</b>	<p><b>Are graduates from Junior Colleges, universities and private education institutions eligible to participate in the WSCerts in Digital Marketing and Branding / for Engineer 4.0 / for Customer Service Associate?</b></p> <p>Yes. These programmes are also open to all graduates from the Autonomous Universities and Private Education Institutions, as well as 'A' Level graduates, subject to the requirements for the specified job role.</p>
<b>11.</b>	<p><b>Will everyone get the training allowance for WSCerts in Digital Marketing and Branding / for Engineer 4.0 / for Customer Service Associate?</b></p> <p>Only Singapore Citizens are eligible for the training allowance.</p>
<b>12.</b>	<p><b>Is there a minimum attendance policy in order to be eligible for incentives?</b></p> <p>Participants are encouraged to have 100% attendance throughout the Programme. Training allowance will only be given upon successful training completion, which is subject to training provider guidelines on attendance.</p>
<b>13.</b>	<p><b>Will participants be required to pay any fees for WSCerts in Digital Marketing and Branding / for Engineer 4.0 / for Customer Service Associate?</b></p> <p>If participants are successfully placed with a participating company after the programme, they will not be required to pay any course fees. The nett course fees payable for the programme will be borne by the employers.</p>

<b>1.</b>	<p><b>How do I register for the programme?</b></p> <p>Follow these steps:</p> <ol style="list-style-type: none"> <li>1) Click <a href="#">here</a> to navigate the programme summary and listing</li> <li>2) Select the programme you are interested</li> <li>3) Click the button "Click here to Apply"</li> <li>4) Log in with <b>Singpass</b></li> <li>5) You will be directed to the application form if you are eligible</li> </ol>
<b>2.</b>	<p><b>What supporting documents am I required to submit with the application form?</b></p> <p>If applicable, you are required to upload your resume, employer verification form, etc. The programme managers administering the application may also contact you to ask for additional information or supporting details.</p>
<b>3.</b>	<p><b>What are the accepted file formats for supporting documents in the system?</b></p> <p>You will be able to upload supporting documents in the following file formats: PDF, DOC, DOCX, JPG/JPEG, PNG</p>
<b>4.</b>	<p><b>What happens when I click on the "Retrieve Myinfo with Singpass" button?</b></p> <p>Your contact number and email address will be auto populated in the application form when you click the "Retrieve Myinfo with <b>Singpass</b>" button.</p> <p>Click <a href="#">here</a> for more details on Myinfo.</p> <p>Note: The contact number and email address that you submit in your application will be auto populated in your subsequent interactions with SSG/WSG e-services.</p>
<b>5.</b>	<p><b>How can I update my personal information that has been automatically displayed in my application form?</b></p> <p>You will be able to update your personal information (e.g. contact number and email address) by clicking the "Retrieve Myinfo with <b>Singpass</b>" button. This will replace the information that is automatically displayed in your application form with data from your Myinfo profile.</p> <p>Click <a href="#">here</a> for more details on Myinfo.</p>
<b>6.</b>	<p><b>What is Skills Passport? How do I edit my Skills Passport for the application form?</b></p> <p>The Skills Passport is a section dedicated to your skills, certificates and licences. The Skills Passport information that you are sharing will be included as part of your application.</p> <p>Steps to edit Skills Passport:</p> <ol style="list-style-type: none"> <li>1) Click "Edit" on the relevant section to make the updates</li> <li>2) Edit your Skills Passport and save accordingly</li> <li>3) Close the tab and go back to the application form</li> <li>4) Click "OK" in a pop-up window to refresh your details</li> </ol>

<b>7.</b>	<p><b>Can I save my application form as a draft?</b></p> <p>Yes. Please click on "Save and Exit" at the bottom of the application page.</p>
<b>8.</b>	<p><b>Where can I retrieve my saved draft application?</b></p> <p>To retrieve saved application draft, follow these steps:</p> <ol style="list-style-type: none"> <li>1) Log in with <b>Singpass</b> to the <a href="#">MySkillsFuture</a> portal</li> <li>2) Click the Dropdown list near your name, and choose "Applications"</li> <li>3) Choose the SkillsFuture Work-Study Programmes Tab</li> <li>4) Under the "Action" column, select "Edit" to continue your application form</li> </ol>
<b>9.</b>	<p><b>Why am I unable to find my saved draft applications in the My Application page?</b></p> <p>Your draft applications are automatically deleted from the system 12 months from the last modified date or when the application window of the particular award is closed.</p>
<b>10.</b>	<p><b>Will I be able to submit multiple applications?</b></p> <p>Yes, you will be able to submit multiple applications across Work-Study Programmes, limited to one application per programme and subject to approval.</p>
<b>11.</b>	<p><b>Will the programme managers, administering my application, able to view my draft applications?</b></p> <p>No, programme managers will not be able to view your saved applications in draft status.</p>
<b>12.</b>	<p><b>What can I do if I realise that I have missed out an attachment in my application submission?</b></p> <p>Please approach the contact person(s) listed in the particular programme webpage that you have applied for, to inform them that you would like to submit additional supporting documents.</p>
<b>13.</b>	<p><b>Can I submit my application through a hardcopy application form?</b></p> <p>No, you will only be able to submit your application online.</p>
<b>14.</b>	<p><b>I have been rejected. Can I reuse the same application to re-apply?</b></p> <p>No, you will not be able to reuse the previously submitted application for a new application. However, to help you in completing your new application, you will be able to retrieve the details of your past applications by navigating to the Applications page.</p>
<b>15.</b>	<p><b>I am in the midst of changing my citizenship to that of a Singaporean Citizen (e.g. Pending IC collection). Will I be eligible?</b></p> <p>Yes, you will be eligible to apply once you have been informed on the effective date of your official citizenship. Please note that the update of your citizenship status by Ministry of Home Affairs (MHA) will require some time before it is recognised by the system.</p>

<b>16.</b>	<p><b>Can I complete an application with my mobile phone?</b></p> <p>Yes, you will be able to complete the application form with your mobile phone.</p>
